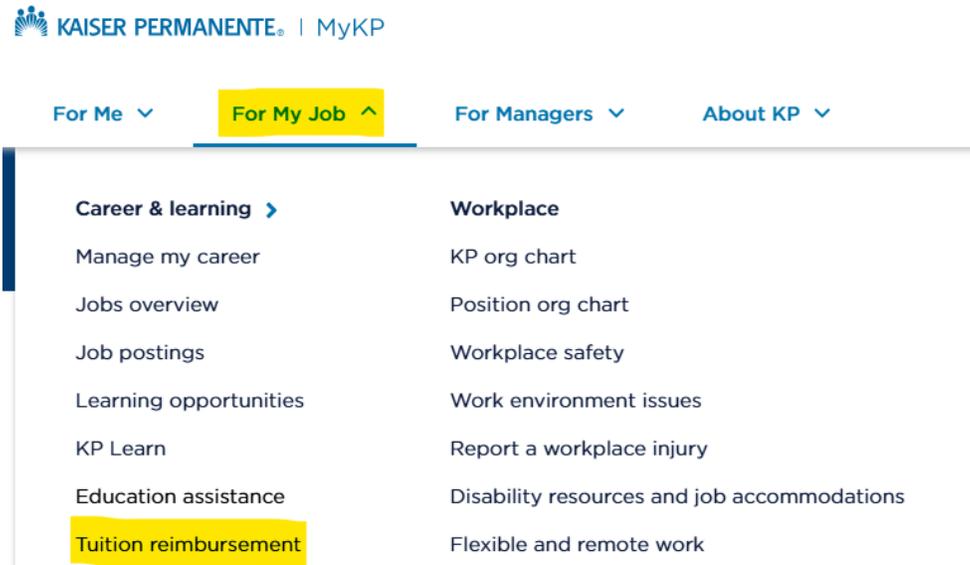


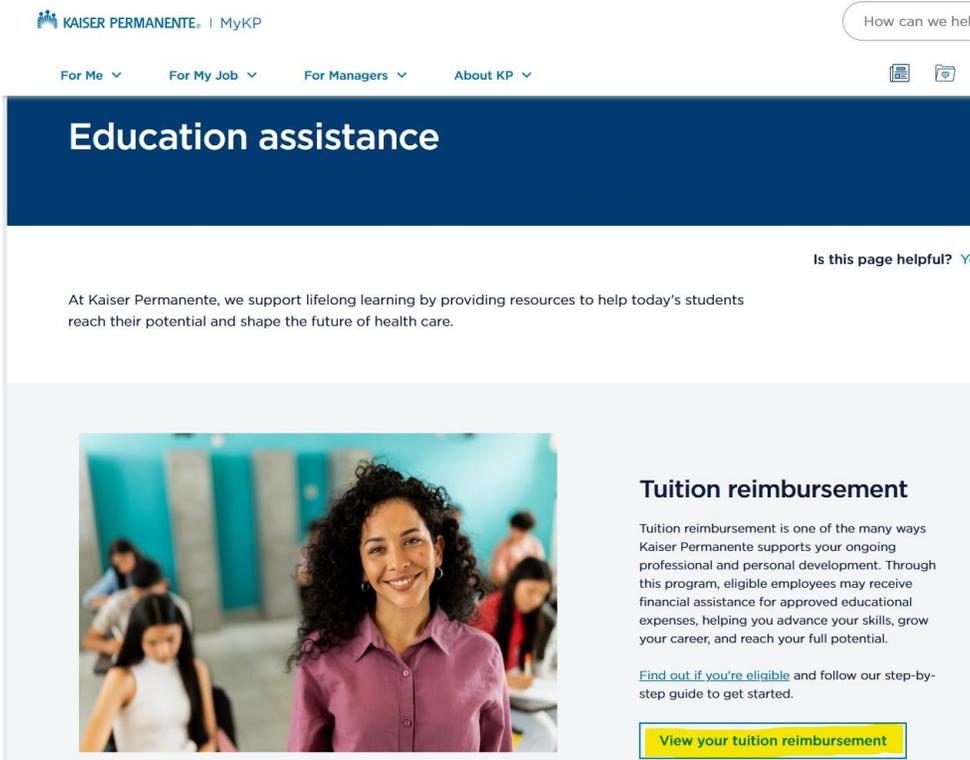

How to submit a tuition reimbursement application on MyKP

1. In MyKP (mykp.kp.org), select the “For My Job” drop-down menu, then select “Tuition reimbursement” in the submenu.



2. In the resulting Education assistance page, find the section for Tuition reimbursement and select “View your tuition reimbursement.”



3. You're now on the tuition reimbursement landing page where you can:

- Submit an application
- View your status and upload supporting documentation
- Review your policy
- View additional resources

Alternatively, you can go directly to this page by visiting wfr.kp.org/tuition. Now select "Start application" to begin filling out your form application details.
